



I understand these risks include, but are not limited to: equipment malfunction and/or failure to function; defective and/or negligent design and/or manufacture of equipment; improper and/or negligent parachute packing and/or assembly; improper and/or negligent operation and/or use of the equipment; aircraft malfunction and/or negligent aircraft operation; carelessness and/or negligent instruction and/or supervision. I voluntarily, freely and expressly choose to incur all risks associated with the activities covered by this Agreement, understanding that those risks may include personal injury, damage to property, and/or death.

EXEMPTION AND RELEASE FROM LIABILITY: I exempt and release the following persons, corporations, and organizations: 1.Kärntner

Fallschirmspringerclub, Flugplatz GmbH Lienz and Flugsportverein Lienz; all aircraft owners, and pilots with whom it contracts for flying services;
